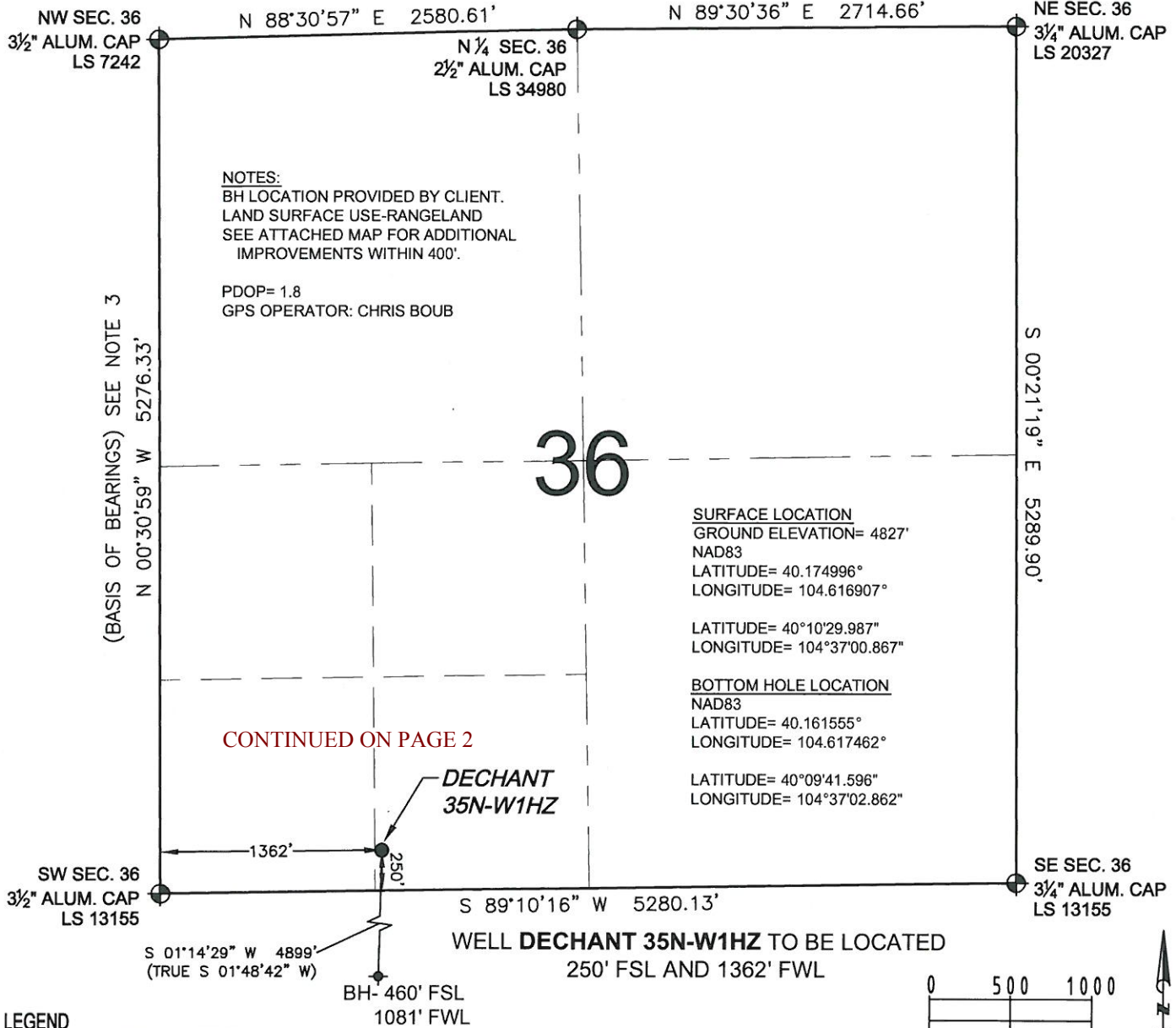

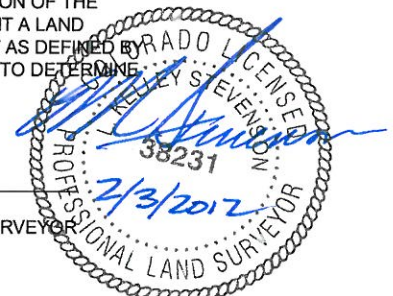

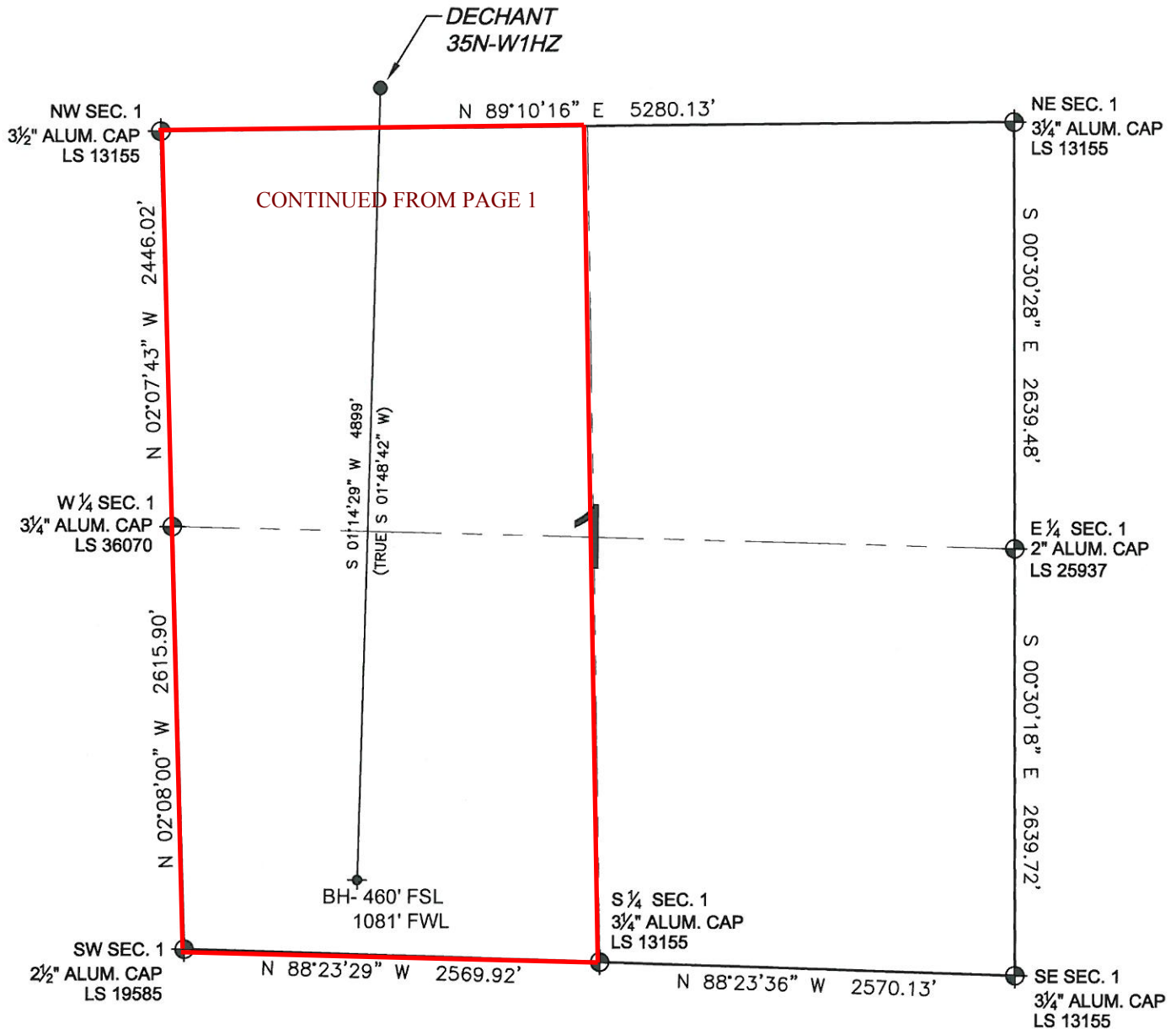

## WELL LOCATION CERTIFICATE: DECHANT 35N-W1HZ



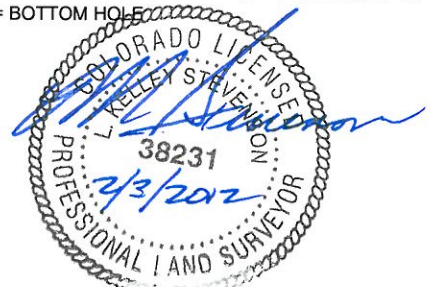
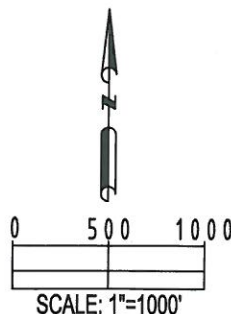
