Bayswater Exploration & Production, LLC plans to drill the above referenced wells, specifically described as:

- Hirsch 13-24 – 448' FNL & 266' FEL
- Hirsch 14-24 – 482' FNL & 232' FEL
- Hirsch 19-24 – 459' FNL & 254' FEL
- Hirsch 23-24 – 471' FNL & 243' FEL
- Hirsch 33-24 – 425' FNL & 288' FEL
- Hirsch 34-24 – 437' FNL & 277' FEL
- Hirsch 35-24 – 493' FNL & 220' FEL
- Hirsch 36-24 – 505' FNL & 209' FEL
- Casa Loma 3-25 – 516' FNL & 198' FEL
- Casa Loma 4-25 – 527' FNL & 186' FEL

Under COGCC Rule 318A.a., a well is required to be within a square with sides 400' in length, the center of which is the center of a governmental quarter-quarter section or within a square with sides 800' in length, the center of which is the center of a governmental quarter section. The wells are being proposed outside of the Greater Wattenberg Drilling Window.

Under COGCC Rule 318A.c. any new twinning well(s) is to be located within 50' of an existing well location. The surface location of Bayswater's proposed wells (as described above) have been staked approximately 11' – 12' apart and more than fifty (50) feet from an existing well location.
