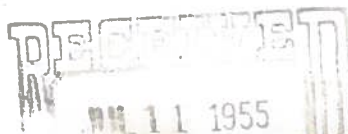

On June 23, 1955, the Hudson Oil and Metals Company, a partnership, filed with the Commission an application for the extension of the area known as the Ignacio Field, with particular reference to that known producing zone located therein and termed "Fruitland-Pictured Cliffs"; and for an order amending its Order No. 3-9, issued May 6, 1954, to provide that all rules and regulations promulgated by said Order No. 3-9 be in all respects applicable to the following described lands in La Plata and Archuleta Counties, Colorado:

Sections 29, 30, 31, 32, and 33: All all in La Plata County, Colorado; Township 32 North, Range 5 West, N. M. P. M. Sections 18, 19, and 20: All in Archuleta County, Colorado.
