Based on review of information presented on your behalf by LT Environmental, Inc, it appears that no further action is necessary at this time, and COGCC approves the oil skim pit No Further Action (NFA) request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be significantly impacted, then further investigation and/or remediation activities may be required at the site. The remediation project #7366 has been changed to closed status in the Colorado Oil & Gas Information System. Please maintain a copy of this email as verification of closure. A copy of the approved Form 27 is attached for your records. The NOAV (#200350687) and Remediation Project (#7094) related to potential impacts from the produced water pit complex remain unresolved; NFA is granted only for the closure of the oil skim pit.

LTE is submitting the attached Loudder 2-X Pit Closure Letter and No Further Action Request and supporting documentation, on behalf of Beren, for oil skim pit closure activities at the above referenced subject site located in the SWSE Sec. 7 T4S R53W. A composite confirmation soil sample was collected from the excavated oil skim pit at this location and analytical results indicate concentrations are compliant with Table 910-1 Concentration Levels. Beren hauled approximately 430 yards of impacted soil to the Buffalo Ridge landfill in Keenesburg, Colorado for disposal. As all impacted soil was removed from the site, Beren is requesting a No Further Action determination for the pit closure.

Beren has replaced the oil skim pit with a skim tank that is already operational. However, the excavation remains open at the site until the NFA is granted by the COGCC. As such, a timely NFA would be greatly appreciated so the pit can be reclaimed before any inclement weather begins to set in.
