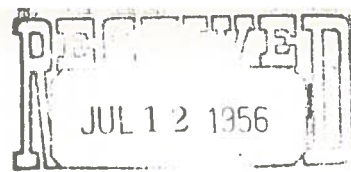

NOTICE OF HEARING
TO ALL INTERESTED PERSONS
AND TO WHOM IT MAY CONCERN:
On June 29, 1956 the Amerada Petroleum Corporation filed with the Commission an application requesting permission and authority to dually complete its A. H. Terrell No. 1 well located in the NE 1/4 of SW 1/4 of NW 1/4 of Section 15, Township 33 North, Range 9 West, N.M.P.M., La Plata County, Colorado, in the Ignacio Field, and to commingle the production therefrom in the well bore.
Also, due to continued development of the Ignacio Area, the Commission, on its own motion, will consider an extension of the area of the Ignacio Field, the additional area to include the following described lands in La Plata County, Colorado, to wit:
Township 33 North, Range 9 West, N.M.P.M.
Sections 19, 28, 29, 30, 31 and 32
Township 33 North, Range 10 West, N.M.P.M.
Sections 4, 5, 8, 9, 15, 16, 21, 22, 23, 24, 25, 26, 27, 28, 33, 34, 35 and 36
Operators are asked to appear and make suggestions regarding the inclusion in the Ignacio Field of all or portions of the above area.
NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to said application, and upon its own motion, has set the above entitled matter down for hearing on:
