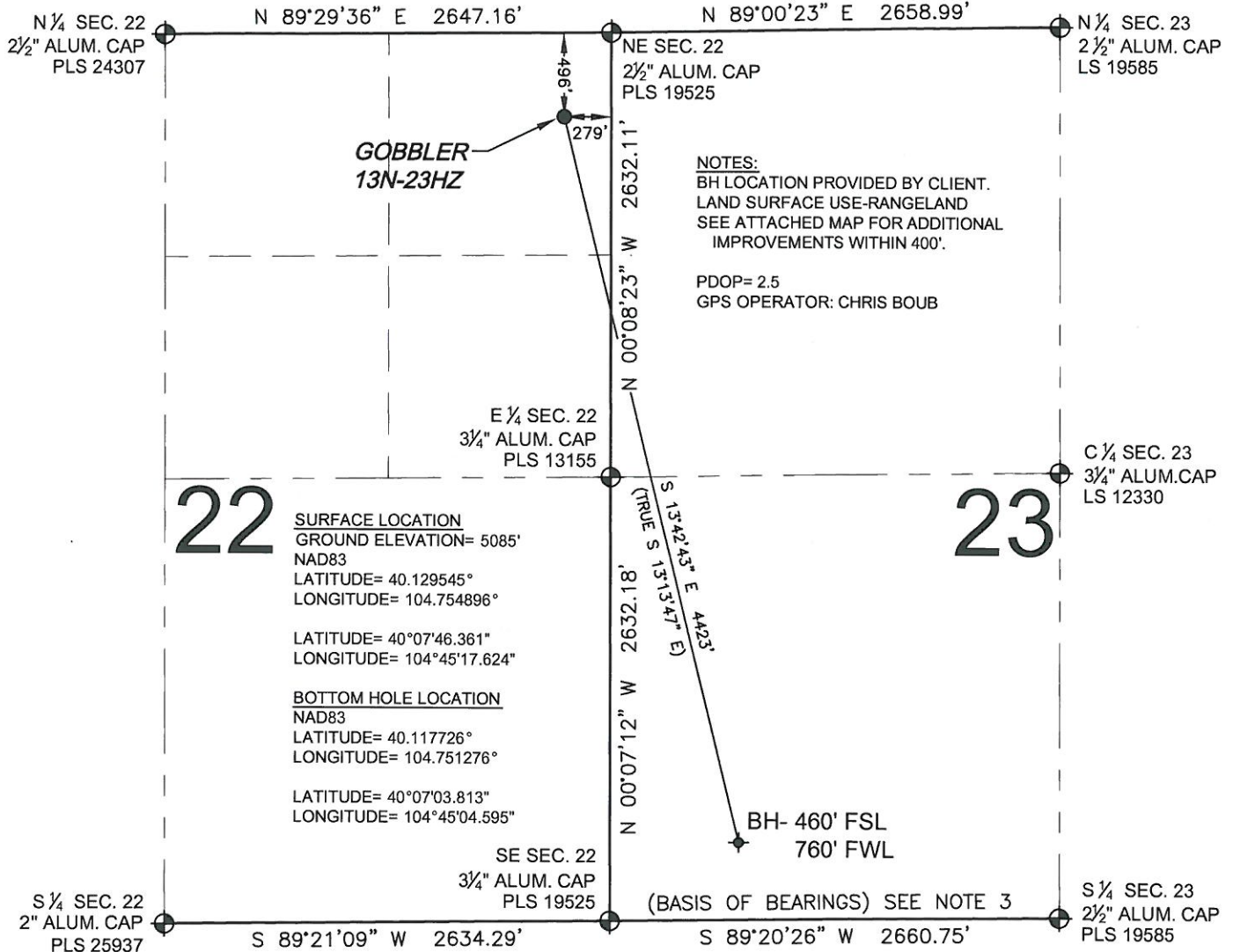


# WELL LOCATION CERTIFICATE: GOBBLER 13N-23HZ
