

The Commission has instituted this proceeding to consider the extension of field limits for the Blanco and Ignacio fields within the following described area in La Plata County, Colorado, to-wit:  
Township 32 North  
Ranges 6, 7, 8, 9, 10, 11  
Township 33 North  
Ranges 6, 7, 8, 9, 10, 11  
Township 34 North  
South of Ute Line  
Ranges 7, 8, 9, 10  
All west of the New Mexico P. M.  
All operators and interested persons are requested to present recommendations to the Commission for revising the present field rules in the causes mentioned above, to include any portion of the above described lands. Because of the close proximity of the Blanco and Ignacio fields, the matter of extension of subject fields will be considered at one hearing.  
Pursuant to said hearing the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
