Based on the information submitted by Noble Energy, Inc. in the Form 19 Spill Report and the Form 27 Site Investigation and Remediation Workplan, it appears that No Further Action is necessary at this time, and COGCC approves Noble's No Further Action request. However, if future conditions at the location are discovered that indicate concentrations of chemicals in excess of COGCC Table 910-1 standards in soil or ground water, further investigation and/or remediation may be required.

The spill tracking number 2231064 has been resolved. This remediation project has been assigned number 7413 and has also been resolved.
