In response to a letter from the Commission requesting recommendations for the extension of the field limits in the Ignacio area, one of the operators requested that all of Townships 32N, 33N, and 34N, Ranges 6W, 7W, 8W, 9W, 10W, and 11W, N.M.P.M., La Plata and Archuleta Counties, Colorado, be considered for possible extension in the Dakota-Morrison and Fruitland Pictured Cliffs formations in the Ignacio Field.

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
