Mason Dixon Energy LLC ("MDE") has been retained by Cascade Petroleum LLC ("Cascade") to assist in its planned oil and gas exploration program in your area. Pursuant to Colorado Oil and Gas Conservation Commission ("COGCC") Rule 306, MDE, acting on behalf of Cascade, hereby provides notice of the following:

1. Cascade intends to commence surface operations for the drilling of the Fisher 13-9S-55W-01H as an exploratory oil and/or gas well following approval by the COGCC of Cascade's Application for Permit to Drill, or within 120 days thereafter.

3. The Fisher 13-9S-55W-01H surface hole location will be located in Section 13-T9S-55W of Lincoln, Colorado.
4. Pursuant to COGCC rules, the surface owner of the subject drill site is responsible for notifying any and all property tenants that may be affected by Cascade's operations.
