GOVERN OPERATIONS IN THE
PADRONI FIELD, LOGAN COUN-

On August 25, 1953, the Commis-
sion issued its Order No. 18-1 which,
among other things, established five
320-acre drilling and spacing units
for production of gas from the "D"
sand formation underlying the
Padroni Field. Subsequent Order
Nos. 18-2 and 18-3 extended the
area and allowed for three addi-
tional gas units.

NOTICE IS HEREBY GIVEN, that
the Oil and Gas Conservation Com-
mission of the State of Colorado, on
its own motion, has set the above-
entitled matter for hearing on:

Since the wells in all the drilling
units, except in Unit No. 1, have
been plugged and abandoned, and
in order to promote future develop-
ment, the Commission has instituted
this proceeding to consider the re-
scinding of provisions of said Order
Nos. 18-1, 18-2 and 18-3 in Cause
No. 18, and substituting in lieu
thereof, the provisions of the gen-
eral rules and regulations of the
Commission.

All operators and owners of work-
ing interests, and any person in-
terested in said Padroni Field, are
hereby requested to appear at the
above-scheduled hearing and show
cause, if any they have, why the
Commission should not repeal the
provisions of Order Nos. 18-1, 18-2
and 18-3.

Pursuant to said hearing in the
above-entitled matter, at the time
and place aforesaid, or at any ad-
journd meeting, the Commission
will enter such orders as it deems
appropriate to prevent the waste of
oil and gas, either or both, in the
operation of the Padroni Field, and
to carry out the purposes of the
statute.
