With your approval, I will change the Form 2A to correct current and future land uses if applicable.
2. In addition to Ascalon NRCS Map Unit, the location is also on the Platner - Ascalon Map Unit. With your approval, I will add this Map Unit to the Form 2A.
3. The Form 2A only lists Blue Grama as plant species. Please provide a list of the other major species present (unless land use is crop land). With your approval, I will add the species to the Form 2A.

In response to the items regarding Forristall State 36-11S-56W-02;

- 1) The vegetation rows appear to be in the SW4 of the section. Our proposed location is located in the NE4, which looks like rangeland. If I am mistaken in this, please let me know and update as necessary.
- 2) Please add additional soil complex for us.
- 3) Based on description of vegetation from the two soil complexes, I would suggest "shortgrasses, predominantly blue grama." Let me know if this is acceptable.

Regarding COAs for the same location;

- 1) Cascade will take necessary measures, such as site grading or the construction of a berm or diversion dike, to protect nearby ephemeral streams from the release of drilling/completion/produced fluids and chemical products. Cascade will take necessary measures to limit displacement and control release of dust resulting from access road use.
- 2) Reference photos will be updated within 12 months.
