Gentlemen:

Encana Oil & Gas (USA) Inc. ("EnCana") has staked six (6) wells from the existing Rasmussen 22-28 well site located in the SE/4NW/4 Section 28, Township 2 North, Range 68 West (see attached survey plats). These wells are being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 318A, known as the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

This rule states that all boundary infill wells be drilled from the same surface locations as previously designated in Rule 318A.a. Rule 318A.a(1) requires a well location to be within a square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section.

The Rasmussen 2-4-28, 11-28, 12-28 wells are staked at a location 6', 16', and 26' west of the defined 400' window. EnCana has staked the wells with your consent and approval and respectfully requests your consent to an exception location for the three (3) Rasmussen wells by waiver of the COGCC Rule 318A.a (1).

If this meets with your approval, please sign and date both originals of this letter, keeping one for your files and returning one to the undersigned.


