Distance to nearest building & railroad is greater than 1 mile. Nearest surface water 1400' NW is an unnamed dry pond. Nearest water well 3436' NW is a stock well; Receipt #9063977, Permit #37155 with a depth of 125' and a static water level of 87'. The reference area is on undisturbed ground immediately adjacent to and West of the facility location as shown in the location photo facing West. Location is the production facilities for two four-well pads; the Timbro LC13-75-1HN Pad (Doc# 400357798) and the Timbro LC13-77-1HN Pad (Doc#400353757). Noble does not have permission to install permanent access to location from the West because of Federal lands; we will be using established access through section 13. No existing equipment. Additional equipment: 1 cold vent blowcase, 1 maintenance tank, 1 compressor suction scrubber, 3 meter buildings, 1 sales gas scrubber, 8 sand catchers, 8 three-phase flowlines, 8 EFM, & 2 water vaults. Surface Use Agreement is attached to the Form 2 for the referenced wells.
