Gentlemen,

Tekton Windsor, LLC (TW) is applying to the Colorado Oil and Gas Conversation Commission (COGCC) to drill the above referenced well at the described surface location. Colorado Oil and Gas Conservation Commission Rule 318A(I).a stipulates that a Greater Wattenberg Area (GWA) well surface location must be within a 400' by 400' drilling window centered at the center of each quarter-quarter section, or inside a 800' by 800' drilling window centered at the center of each quarter section. The above well surface locations fall outside of these windows.

Additionally, COGCC Rule 318A(I).c stipulates that a GWA well surface location shall not be less than 50' from an existing well. As planned, this well surface location is greater than 50' from an existing well.

Per COGCC Rules TW is required to get surface owner approval of this location and a waiver of said rules 318A(I).a and 318A(I).c. The well is spotted as above in order to minimize surface disturbance while complying with your wishes and the Surface Use Agreement.
