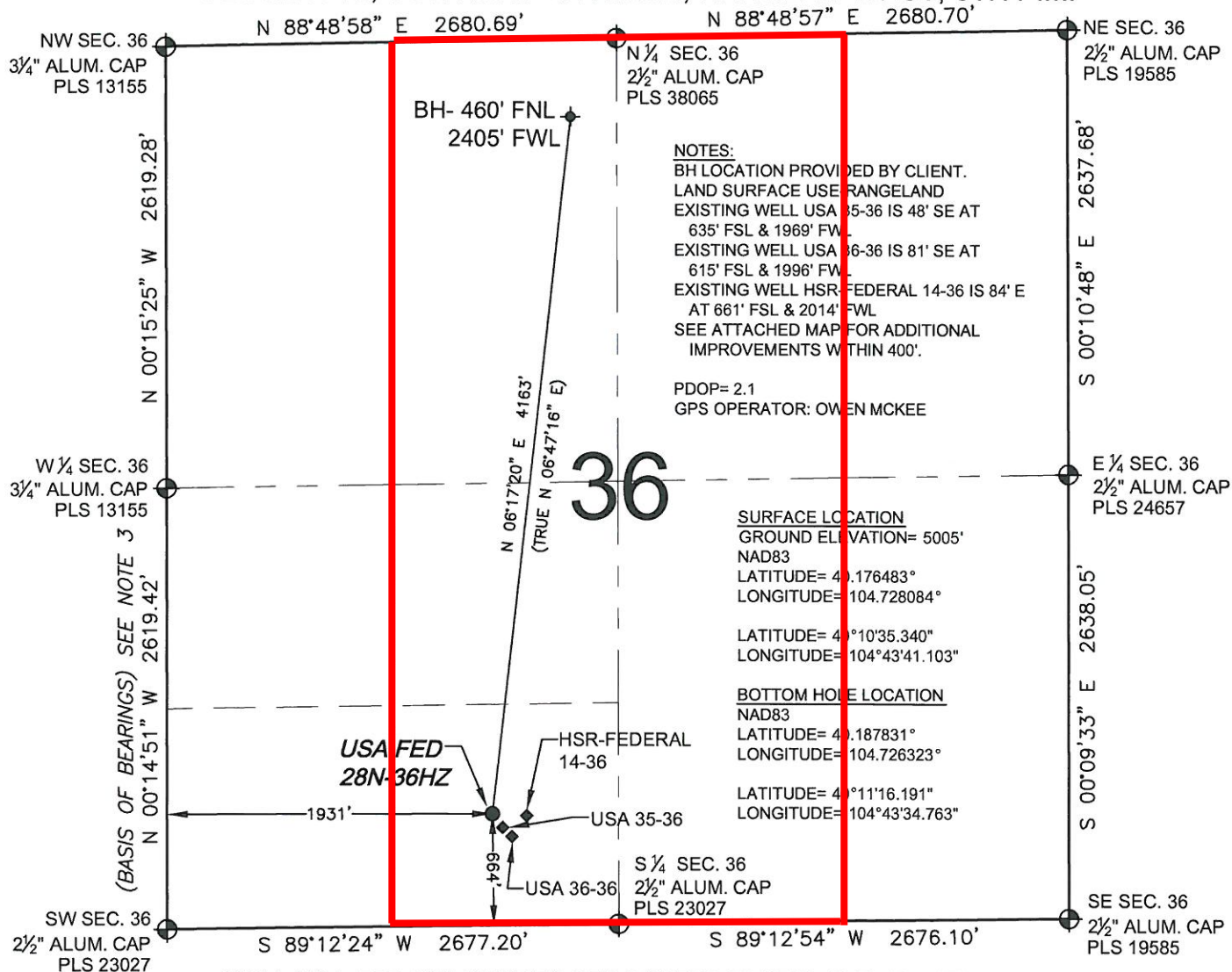

## WELL LOCATION CERTIFICATE: USA FED 28N-36HZ

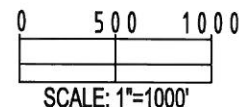

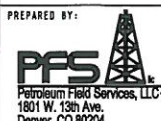
