The pad is located in Project Rulison 3-Mile Radius Tier II. DOE was notified 7/16/10. This well is part of the Battlement Mesa Pad 35L. I certify that all conditions in the original permit are the same except for the change of location noted on the sundry submitted in 2011 and the bottom hole location noted on the updated survey plat. Updated survey plat and directional survey with new TD were submitted with Sundry. There have been no other changes to land use, well construction or the lease. This pad has been built. This well was mistakenly abandoned per sundry submitted 11/21/12.
