I certify that all conditions in the original permit are the same except for the change of location noted on the sundry submitted in 2011, the bottom hole location (noted on the updated survey plat submitted with the sundry), and the proposed total measured depth and the 1st string setting depth and cement bottom casing have changed based on the updated directional survey (submitted with sundry). There have been no other changes to land use, well construction or the lease. This Pad has been built.
