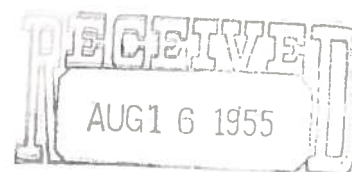

The Commission has heretofore issued its Order No. 26-21, which provides in part that the order shall be in effect for a period of two months, beginning July 1, 1955.

All operators and owners of working interests, and all persons interested in the said field, are hereby required to appear at the hearing as set forth above, and to show cause, if any they have, why the Commission should not issue an order continuing the provisions of Order No. 26-21, or an order similar thereto.

NOTICE IS FURTHER GIVEN, that at this hearing, the Commission, upon its own motion, will consider an extension of the area of the Adena Field, the additional area to be spaced the same as set forth in Order No. 26-16, and to include the following described lands:

Township 1 North, Range 57, West,  
6th P.M.

Section 4: E/2 Section 16: E/2  
Section 9: E/2 Section 21: E/2

Township 2 North, Range 57 West,  
6th P.M.

Section 28: E/2 Section 33: E/2  
all in Morgan County, Colorado.

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field.
