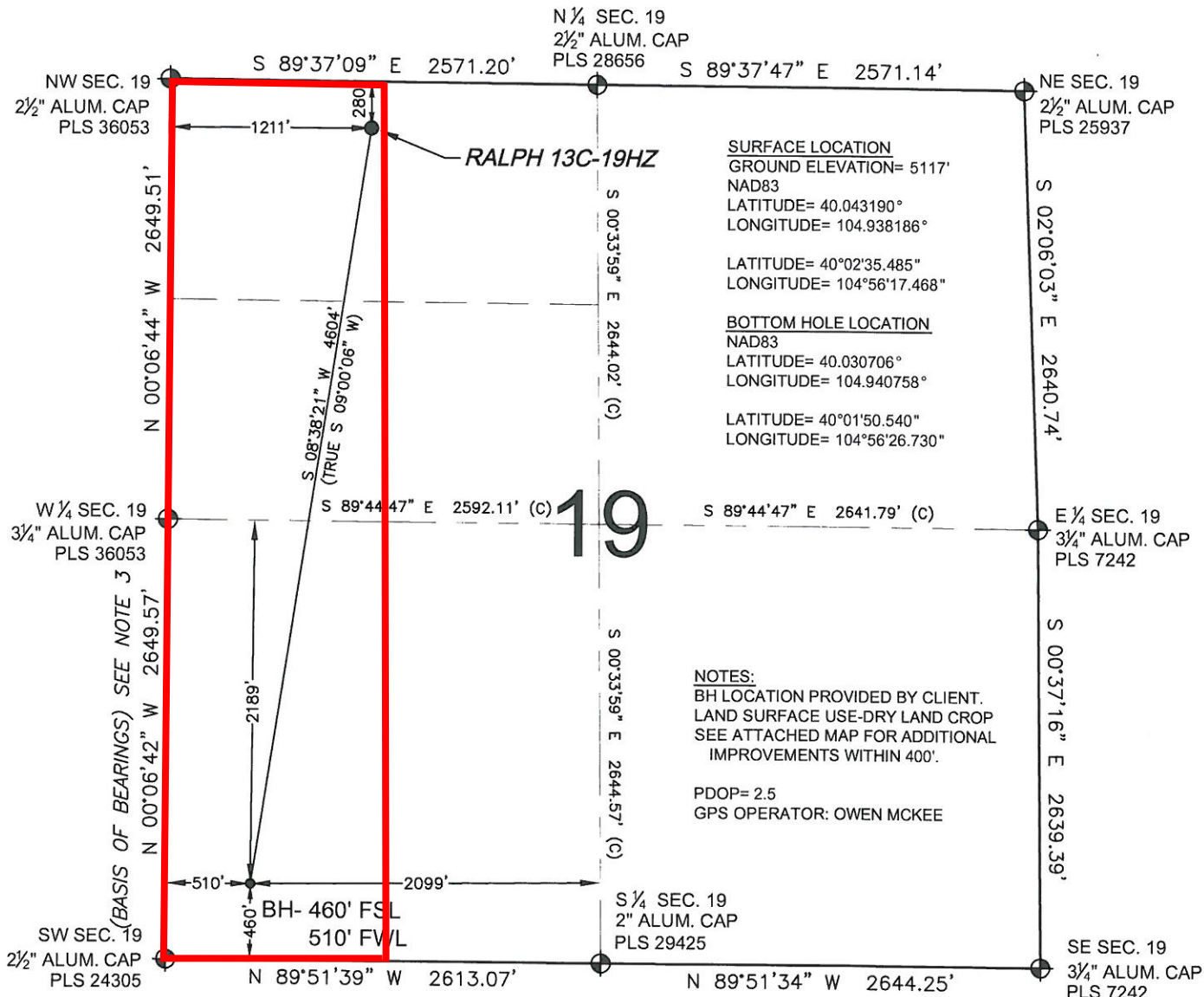

WELL LOCATION CERTIFICATE: RALPH 13C-19HZ

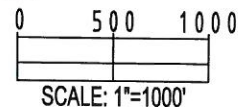
