



King Surveyors Inc. has determined the surface location of the WASTE MGMT 2i-221 to be 230' from the SOUTH line and 650' from the WEST line, the entry point to be 500' from the SOUTH line and 485' from the WEST line and the bottom hole to be 500' from the NORTH line and 485' from the WEST line, as measured at right angles, from the section lines of Section 2, Township 2 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 12-7-2012, for and on behalf of PDC ENERGY, INC., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.


