On February 17, 1978, the Commission issued its Order No. 304-1 which, among other things, established 320-acre drilling and spacing units for the production of gas from the Sussex formation underlying certain lands in the Hambert Field, Weld County, Colorado.
On October 1, 1978, Amoco Production Company, filed with the Commission an application for an order further extending the limits of the Hambert Field to include the following described lands in Weld County, Colorado, to-wit:

and further providing that such additional area be made subject to the provisions of Order No. 304-1, and that Well No. 1 Edward Hemple, located in the NW $\frac{1}{4}$ of said Section 20 be the permitted well for the designated unit consisting of the W $\frac{1}{4}$ of said Section 20.
