All representations, stipulations and conditions of approval stated in this Form 2A for this location shall constitute representations, stipulations and conditions of approval for any and all subsequent operations on the location unless this Form 2A is modified by Sundry Notice, Form 4 or an Amended Form 2A.

As a Condition of Approval, the COGCC requires submittal of an E&P Waste Management Plan (WMP) for the offsite placement/burial of the water-based mud and cuttings. The plan is required to maintain compliance with COGCC Rule 907.d. The plan shall be provided with a Form 4 Sundry Notice and include descriptions of the material, procedures for handling/placement, and tracking of quantity and quality of the material. The plan must be approved by COGCC prior to commencing construction at the location.

For drying and burial, per Rule 907.d.(3)A, the water-based bentonitic drilling fluids shall be sampled and resulting concentrations shall not exceed the concentration levels in Table 910-1. For land application, sampling and resulting concentrations shall be in accordance with Rule 907.d.(3)B.ii.

Written authorization from the surface owner will also be required.
