On December 20, 1984, the Commission issued Order No. 407-1 which, among other things, established 80-acre drilling and spacing units for the production of oil and/or gas from the Codell formation underlying certain lands in Adams, Boulder, Jefferson, Larimer and Weld Counties, Colorado. The units consist of the E $\frac{1}{2}$  and W $\frac{1}{2}$  or the N $\frac{1}{2}$  and S $\frac{1}{2}$  of a governmental quarter section. The N $\frac{1}{2}$  NE $\frac{1}{4}$  Section 24, Township 5 North, Range 65 West, 6th P.M., has been designated a drilling and spacing unit.

On September 6, 1984, RA Resources, Inc., by its attorney, filed with the Commission a verified application for an order pooling all interests in the unit consisting of the N $\frac{1}{2}$  NE $\frac{1}{4}$  Section 24, Township 5 North, Range 65 West, 6th P.M., Weld County, Colorado for the development and operation of the Codell formation for the production of oil and/or gas underlying said unit, pursuant to 34-60-116, C.R.S. 1973, as amended.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

Any interested party desiring to protest the granting of the application should file with the Commission a written protest no later than October 10, 1984, briefly stating the basis of the protest, and such interested party shall, at the same time, serve or mail a copy of the protest to the person filing the application.
