**NOTICE OF HEARING  
BEFORE THE OIL AND GAS  
CONSERVATION COMMISSION OF  
THE STATE OF COLORADO  
CAUSE NO. 232  
IN THE MATTER OF THE PROMULGATION AND ESTABLISHMENT OF FIELD RULES TO GOVERN OPERATIONS IN THE WATTENBERG GAS SPACED AREA, ADAMS COUNTY, COLORADO  
TO ALL PERSONS AND TO WHOM IT MAY CONCERN:**

On July 18, 1977, the Commission issued Order No. 232-16 which restricted production of gas from the "J" Sand from Well No. 20-4 Smith, located 800 feet from the north line and 800 feet from the west line Section 20, Township 2 South, Range 64 West, 8th P.M., since the well was drilled off-pattern to the permitted well provisions of the orders in Cause No. 232 for the Wattenberg Gas Spaced Area. On November 17, 1981 the Commission issued Order No. 232-23 which permitted the drilling of an additional well on each 320-acre drilling and spacing unit in the Wattenberg Gas Spaced Area.

On March 4, 1983, Sohio Petroleum Co., by its attorneys, filed with the Commission an application for an order to remove the production restrictions as established by Order No. 232-16 for said Well No. 20-4 Smith since such restrictions are no longer necessary.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

DATE: Monday, May 16, 1983

TIME: 9:00 a.m.

PLACE: Room 110, State Centennial Building, 1313 Sherman Street, Denver, Colorado 80203

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

Any interested party desiring to protest the granting of the application should file with the Commission a written protest no later than May 11, 1983, briefly stating the basis of the protest, and such interested party shall, at the same time, serve or mail a copy of the protest to the person filing the application.
