On November 17, 1970, the Commission issued Order No. 232-1
which established 320-acre drilling and spacing units for the
production of gas and associated hydrocarbons from the "J"
underlying lands in the E1/2 and W1/2 or the N1/2 and S1/2 of each
section according to the governmental survey, with the permitted
well located in the SW1/4 and NE1/4 of each section. Subsequent
orders extended the limits of the spaced area and allowed an
additional well to be drilled on each 320-acre unit. The E1/2 Section
20, Township 1 North, Range 65 West, has been designated a unit.
On March 1, 1985, Berge Exploration, Inc., by its attorneys, filed
with the Commission a verified application for an order pooling all
interests in the unit consisting of the E1/2 Section 20, Township 1
North, Range 65 West, for the development and operation of the "J"
Sand for production of gas and associated hydrocarbons underlying
said unit, pursuant to 34-60-116 C.R.S., as amended.
NOTICE IS HEREBY GIVEN, that the Oil and Gas Conserva-
tion Commission of the State of Colorado, pursuant to the above, has

the protest to the person filing the application.
