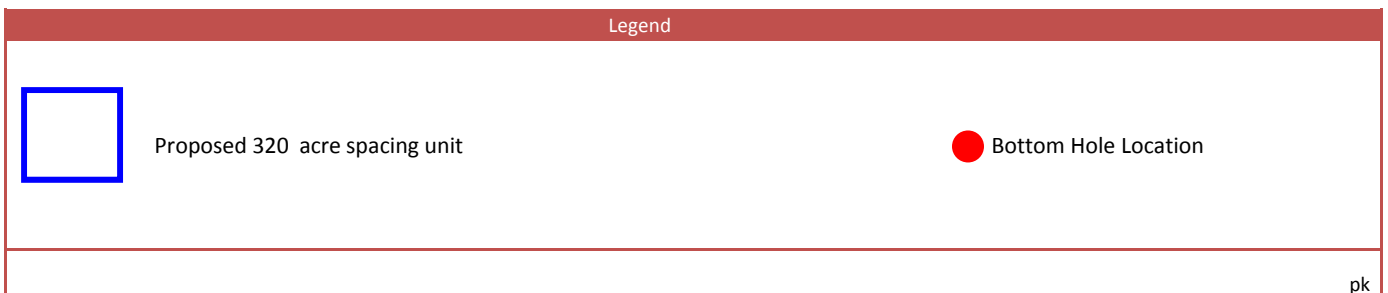

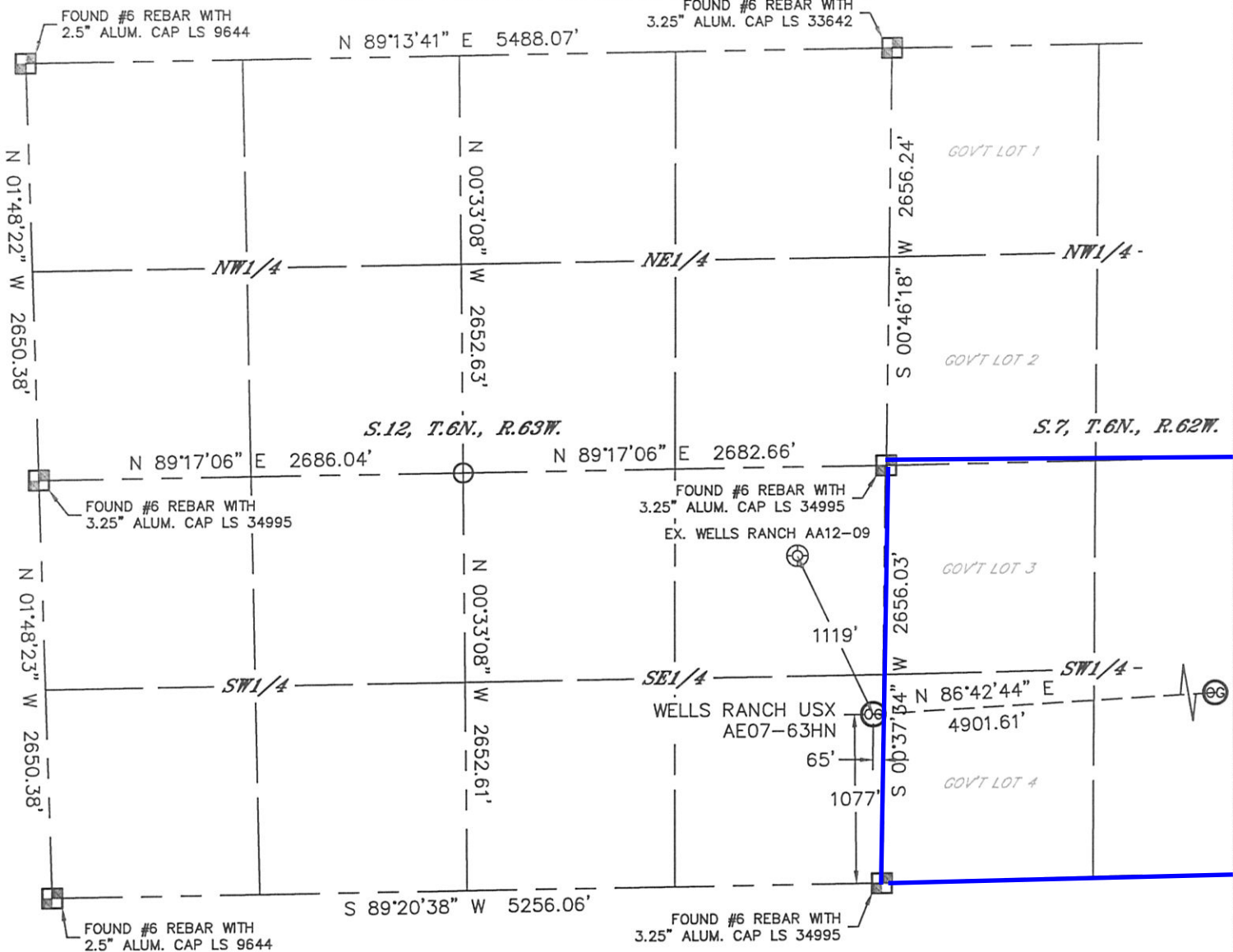
Proposed Spacing Unit – Noble Energy, Inc

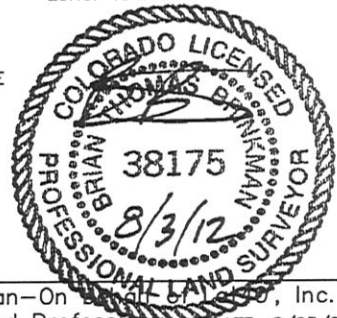

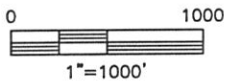
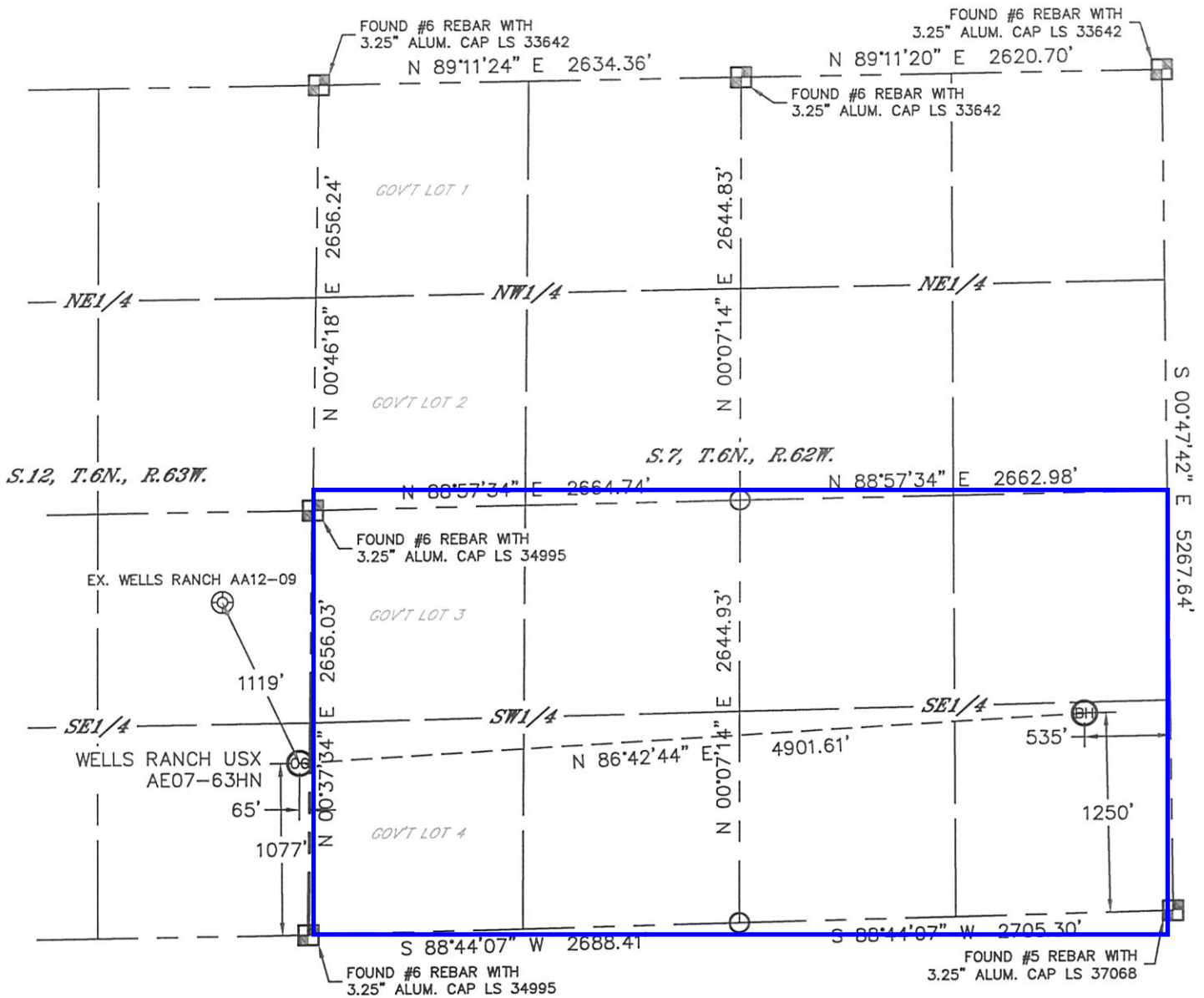

WELL LOCATION CERTIFICATE

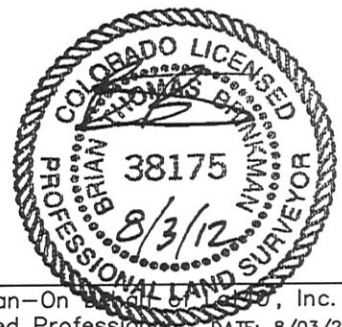
