 cording to the governmental survey
 thereof, for the "D" and "J" sands
 underlying:

6th P.M.

Section 33: SE $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$

Section 34: All

Section 35: W $\frac{1}{2}$

Township 8 North, Range 53 West,

6th P.M.

Section 2: Lots 1, 2, 3 and 4, includ-
 ing any lands lying be-
 tween said lots and the
 township line on the
 north.

Section 3: Lots 1, 2, 3 and 4, includ-
 ing any lands lying be-
 tween said lots and the
 township line on the
 north;

which area is presently referred to
 as the Minto-West Field, Logan
 County, Colorado.

The petition also asks that each
 well drilled in accordance with the
 spacing pattern to be established,
 be permitted, at the option of each
 operator, to be produced simultane-
 ously from the "D" Sand and the
 "J" Sand.

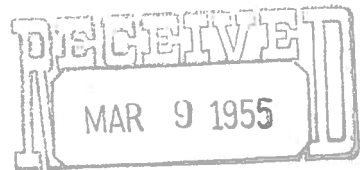
