IN THE MATTER OF THE PROMULGATION AND ESTABLISHMENT OF FIELD RULES TO GOVERN OPERATIONS IN THE GREENWOOD FIELD, BACA COUNTY, COLORADO TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:

On July 3, 1985, Gary Sandlin, by his attorney, filed with the Commission a verified application for an order establishing a 640-acre, more or less, drilling and spacing unit for the production of gas and associated hydrocarbons from the Topeka Limestone formation and consisting of the following described land in a portion of the Greenwood Field, Baca County, Colorado, to-wit:

Township 31 South, Range 41 West, 6th P.M.

Section 18 Resurvey Tract 65: Lots 6, 7, 8, 15, 17 and 19

Resurvey Tract 66: Lots 16, 18, 20, 24, 25, 26, 33, 35, and 37

Resurvey Tract 67: Lots 9, 10, 11 and 13

Resurvey Tract 68: Lots 12, 14, 27, 28, 29 and 31

Resurvey Tract 71: Lots 34, 36 and 38
Township 31 South, Range 42 West, 6th P.M.

Section 13: Resurvey Tract 67: Lots 2, 18 and 19

Resurvey Tract 68: Lots 1, 20 and 36 and that Well No. 1-18 Bryan, located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 18, Township 31 South, Range 41 West, 6th P.M. be considered the permitted well for the Unit.

It is further requested that all interests in the Unit described hereinabove be pooled for the operation and development of the gas and associated hydrocarbons from the Topeka Limestone formation underlying said Unit in accordance with 34-60-116 C.R.S., as amended, effective as of March 29, 1985.

NOTICE IS HEREBY GIVEN, that the Oil and Gas Conservation Commission of the State of Colorado, pursuant to the above, has scheduled the above-entitled matter for hearing on:

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

Any interested party desiring to protest the granting of the application should file with the Commission a written protest no later than August 14, 1985, briefly stating the basis of the protest, and such interested party shall, at the same time, serve or mail a copy of the protest to the person filing the application.
