## NOTICE OF HEARING

TO ALL INTERESTED PER-  
SONS AND TO WHOM IT  
MAY CONCERN:

On June 3, 1964, the Commission  
issued its Order No. 36-1 which,  
among other things, established  
40-acre drilling and spacing units  
for the production of oil from the  
"D" sand formation underlying the  
Gary Field. Subsequent Order No.  
36-2 deleted certain lands from  
the spaced area.

NOTICE IS HEREBY GIVEN,  
that the Oil and Gas Conservation  
Commission of the State of Colo-  
rado, on its own motion, has set  
the above-entitled matter for hear-  
ing on:

DATE: Tuesday, November 19,  
1968.

TIME: 10 a.m.  
PLACE: Conference Room 260;  
Columbine Building; 1845 Sherman  
Street; Denver, Colorado.

Since all wells in the spaced area  
are now plugged and abandoned,  
and in order to promote future de-  
velopment, the Commission has in-  
stituted this proceeding to con-  
sider the rescinding of provisions  
of said Order Nos. 36-1 and 36-2  
in Cause No. 36, and substituting  
in lieu thereof, the provisions of  
the general rules and regulations  
of the Commission.

All operators and owners of  
working interests, and any per-  
son interested in said Gary Field,  
are hereby requested to appear at  
the above-scheduled hearing and  
show cause, if any they have, why  
the Commission should not repeal  
the provisions of Order Nos. 36-1  
and 36-2.

Pursuant to said hearing in the  
above - entitled matter, at the  
time and place aforesaid, or at  
any adjourned meeting, the Com-  
mission will enter such orders as  
it deems appropriate to prevent  
the waste of oil and gas, either or  
both, in the operation of the Gary  
Field, and to carry out the pur-  
poses of the statute.
