**REQUEST TO WITHDRAW APPEAL**



Gunnison County, Colorado ("Gunnison County" or the "County") by and through the County Attorney, David Baumgarten and Sullivan Green Seavy LLC, hereby submits its Request to Withdraw Appeal, and states as follows:

1. In a letter to Director Matt Lepore dated September 28, 2012, and pursuant to Rule 305.d.(2) and Rule 503.b.(7).C, Gunnison County requested that a hearing be conducted by the COGCC on the approval of an Application for Permit-to-Drill, Form 2, and on the approval of an Oil and Gas Location Assessment, Form 2A for SG Interests' Federal 11-90-9 #3 Well ("Request for Hearing").
2. Since the Request for Hearing was filed, the County, COGCC Director Lepore, and SG Interests have had an opportunity to consult and discuss the County's concerns that served as the reasons for its appeal.
3. On the basis of that consultation, Gunnison County respectfully requests leave to withdraw this appeal.


