On October 3, 1955, the Southern Union Gas Company, a Delaware corporation, filed with the Commission an application requesting an order approving the dual completion of its Ute No. 3 well located 990 feet north of the south line and 900 feet east of the west line of Section 22, Township 32 North, Range 11 West, N.M.P.M., and its Farmer No. 1 well located 900 feet from the north line and 1040 feet from the east line of Section 15, Township 32 North, Range 11 West, N.M.P.M., both wells being situated in the Blanco-Mesaverde Field, La Plata County, Colorado.
