IN THE MATTER OF THE INVESTIGATION TO TAKE MEASURES TO PREVENT WASTE OF OIL AND GAS IN THE BLANCO-MESAVERDE FIELD, LA PLATA COUNTY, COLORADO.  
TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:

On October 3, 1955, the Southern Union Gas Company, a Delaware corporation, filed with the Commission an application requesting an order approving the dual completion of its Ute No. 3 well located 990 feet north of the south line and 900 feet east of the west line of Section 22, Township 32 North, Range 11 West, N.M.P.M., and its Farmer No. 1 well located 900 feet from the north line and 1040 feet from the east line of Section 15, Township 32 North, Range 11 West, N.M.P.M., both wells being situated in the Blanco-Mesa-verde Field, La Plata County, Colorado.

Also, the Southern Union Gas Company filed with the Commission an application requesting an order approving the dual completion of its Ute No. 4-A well located 990 feet south of the north line and 990 feet west of the east line of Section 21, Township 32 North, Range 11 West, N.M.P.M., in the Blanco-Mesa-verde Field, La Plata County, Colorado.

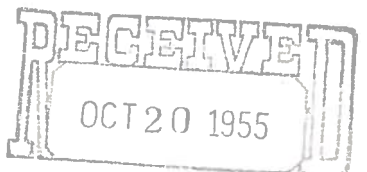
