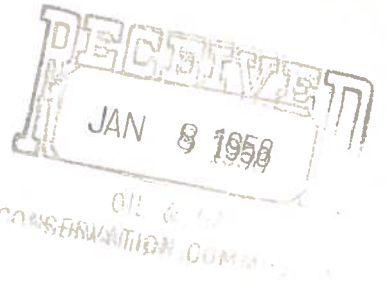

NOTICE OF HEARING BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO CAUSE NO. 30 IN THE MATTER OF THE INVESTIGATION TO TAKE MEASURES TO PREVENT WASTE OF OIL AND GAS IN THE "J" SAND OF THE LITTLE BEAVER FIELD, WASHINGTON AND ADAMS COUNTIES, COLORADO. TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:

On October 15, 1957, the Commission issued its Order No. 30-12, continuing the provisions of Order No. 30-8, and setting a hearing in the above entitled cause for approximately January 28, 1958, for the purpose of receiving reports as to progress made with reference to unitization of the "J" sand reservoir of the Little Beaver Field, and reconsideration of field rules.

NOTICE IS HEREBY GIVEN, that The Oil and Gas Conservation Commission of the State of Colorado, upon its own motion, has set the above entitled matter down for hearing on:

DATE: Tuesday, January 28, 1958

TIME: 10:00 A.M.

PLACE: Game Room, Albany Hotel, Denver, Colorado

At the above hearing, operators are requested to be prepared to submit testimony and recommendations for or against any change in field rules for the "J" sand reservoir of the Little Beaver Field.

All persons interested in such matters are invited to appear and be heard on the above date.

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
