

NOTICE OF HEARING BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO

CAUSE NO. 30
IN THE MATTER OF THE INVESTIGATION TO TAKE MEASURES TO PREVENT WASTE OF OIL AND GAS IN THE "D" SAND OF THE LITTLE BEAVER FIELD, WASHINGTON AND ADAMS COUNTIES, COLORADO.

TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:

On March 3, 1959, the Continental Oil Company, as Unit Operator of the Little Beaver "D" Sand Unit, Washington County, Colorado, filed with the Commission an application for an order approving (1) enlargement of said Unit Area to include the NW $\frac{1}{4}$ SW $\frac{1}{4}$ and the E $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 5, Township 2 South, Range 56 West of the 6th P.M., Washington County, Colorado; (2) inclusion in the Unit Area of the two 20-acre tracts consisting of the W $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ and W $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 5, Township 2 South, Range 56 West, 6th P.M., Washington County, Colorado, upon which tracts the No. 1 and No. 5 Wheatlake wells are located, when said wells are capable of producing ten barrels of oil per day due to an expanded water flood project; and (3) conversion of Unit wells 58, 63, 68, 74 and 75 to water injection wells.

NOTICE IS HEREBY GIVEN, that The Oil and Gas Conservation Commission of the State of Colorado, pursuant to said application, has set the above entitled matter for hearing on:
