

5. DESCRIBE PROPOSED OR COMPLETED OPERATIONS

WPX has observed bradenhead pressure on the subject well in the Grand Valley Field on the SG 44-23 Well Pad. WPX requests permission to vent the bradenhead gas by running a hardline to a tank for 90 days. Well information is as follows:

Once the sundry expires, we'll get a 24 hour and 7 day build up test on the well to see if the pressure has started to deplete.
