On July 31, 1956, the Commission issued its Order No. 26-30 which, in part, sets forth a formula for determining the basic daily "J" sand oil allowable for each producing tract, and a formula for determining the basic gas allowable for each producing tract in the Adena Field. On September 26, 1957, the Commission received a Well Completion Report, OGCC Form 5, from the Monsanto Chemical Company, Lion Oil Company Division, for the Robison Well No. 2, located in the SE/4 NW/4 SW/4 of Section 25, Township 1 North, Range 58 West of the Sixth P. M., Morgan County, Colorado, which well was completed as an oil well in the "J" sand reservoir of the Adena Field, and lies outside the Adena "J" Sand Unit.

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
