

**NOTICE OF HEARING**  
BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO  
CAUSE NO. 26  
IN THE MATTER OF THE PROMULGATION AND ESTABLISHMENT OF FIELD RULES TO GOVERN OPERATIONS IN THE "J" SAND OF THE ADENA FIELD, MORGAN COUNTY, COLORADO.  
TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:  
On January 23, 1957, the Commission issued its Order No. 26-33, which in part, established an oil allowable of forty (40) barrels per day for a period of one year, commencing February 1, 1957, for the Delaney No. 1 well, located in the SE/4 SE/4 NE/4, Section 26, Township 1 North, Range 58 West, Morgan County, Colorado; and also, for a period of one year, commencing February 1, 1957, removed the restrictive limits of oil and gas production for Tract No. 81-B as set forth in Order No. 26-31, issued the 25th day of October, 1956.  
NOTICE IS HEREBY GIVEN, that The Oil and Gas Conservation Commission of the State of Colorado, upon its own motion, has set the above entitled matter down for hearing on:  
DATE: Tuesday, January 28, 1958  
TIME: 10:00 A.M.  
PLACE: Game Room, Albany Hotel, Denver, Colorado  
The Commission has set this hearing to determine a just and reasonable allowable for oil production from said Delaney No. 1 well after February 1, 1958, and to determine if the restrictive limits of Order No. 26-31 should apply to Tract No. 81-B after February 1, 1958.  
All interested persons are hereby invited to appear at the above hearing and to submit testimony and recommendations in this matter.  
Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
