Details of work:

Control well w/ kill fluid. RIH w/ blade bit, and scraper, 221 jts. Tagged fill at 7186' KB. TIH w/ RBP, retrieved head, 223 jts 1 1/4" tubing. Set RBP @ 6968' KB w/ 223 jts. Roll hole clean. PSI test csg to 1100#, with no pressure loss. Dump 1 sk of sand on plug. Unland casing.

Pick Up mule shoe and TIH w/24 jts of 1 1/4" to 775'. Pump 270 sks of "G" neat 15.8 ppg cement from 742' to surface. Reland casing. Bond log from 1000' to surface. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land tubing to 7108'. Rig down and move off.
