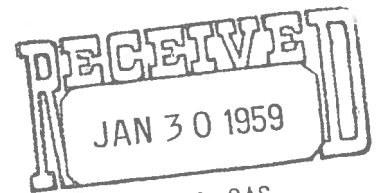

On June 19, 1958, the Commission issued its Order No. 26-40 which, in Rule 2, provided in part that income derived from the allowable production obtained from the Delaney No. 1 and No. 2 wells located in Section 26, Township 1 North, Range 58 West, Morgan County, Colorado, shall be combined to pay-out the Delaney No. 2 well; and in Finding 8 thereof stipulated that the Commission should hold a hearing at the approximate time of such pay-out to accept and review additional pertinent information for determination of an allocation for Tract 81-B.
