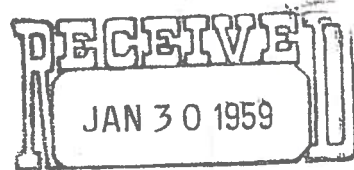

### NOTICE OF HEARING BEFORE THE OIL AND GAS CONSERVATION COMMISSION OF THE STATE OF COLORADO

CAUSE NO. 28

IN THE MATTER OF THE PROMULGATION OF FIELD RULES TO GOVERN OPERATIONS IN THE "J" SAND OF THE ADENA FIELD, MORGAN COUNTY, COLORADO.

TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:

On June 19, 1958, the Commission issued its Order No. 26-40 which, in Rule 2, provided in part that income derived from the allowable production obtained from the Delany No. 1 and No. 2 wells located in Section 26, Township 1 North, Range 58 West, Morgan County, Colorado, shall be combined to pay-out the Delaney No. 2 well; and in Finding 8 thereof stipulated that the Commission should hold a hearing at the approximate time of such pay-out to accept and review additional pertinent information for determination of an allocation for Tract 81-B.

NOTICE IS HEREBY GIVEN, that The Oil and Gas Conservation Commission of the State of Colorado, pursuant to said Order No. 26-40, has set the above entitled matter for hearing on:

TIME: 10:00 a.m.

PLACE: Auditorium, Department of Employment Building (main floor), 251 East 12th Avenue, Denver, Colorado

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.

All interested persons are hereby invited to appear and be heard at the above hearing.
