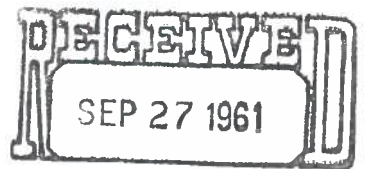

TO ALL INTERESTED PERSONS
AND TO WHOM IT MAY CON-
CERN:

On September 19, 1961, The Pure Oil Company filed with the Commission an application for an order designating the NE $\frac{1}{4}$ and N $\frac{1}{4}$ SE $\frac{1}{4}$ Section 13, Township 1 North, Range 58 West, and S $\frac{1}{4}$ SW $\frac{1}{4}$ Section 7 and NW $\frac{1}{4}$ and N $\frac{1}{4}$ SW $\frac{1}{4}$ Section 18, Township 1 North, Range 57 West, 6th P.M. Morgan County, Colorado, as a separate common source of supply of gas from the "D" sand, this area to be designated as a Unit for the production of gas from the "D" sand; and that this unit be given an allowable of 1,050,000 cubic feet of gas per day from the "D" sand, and classify The Pure Oil Company's H. J. Clar No. 6 well located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 13, Township 1 North, Range 58 West as a gas well in the "D" sand; that it be the permitted well in this Unit for the production of gas from the "D" sand; and that this Commission issue such other rules and regulations as it shall determine necessary or proper in the matter.
