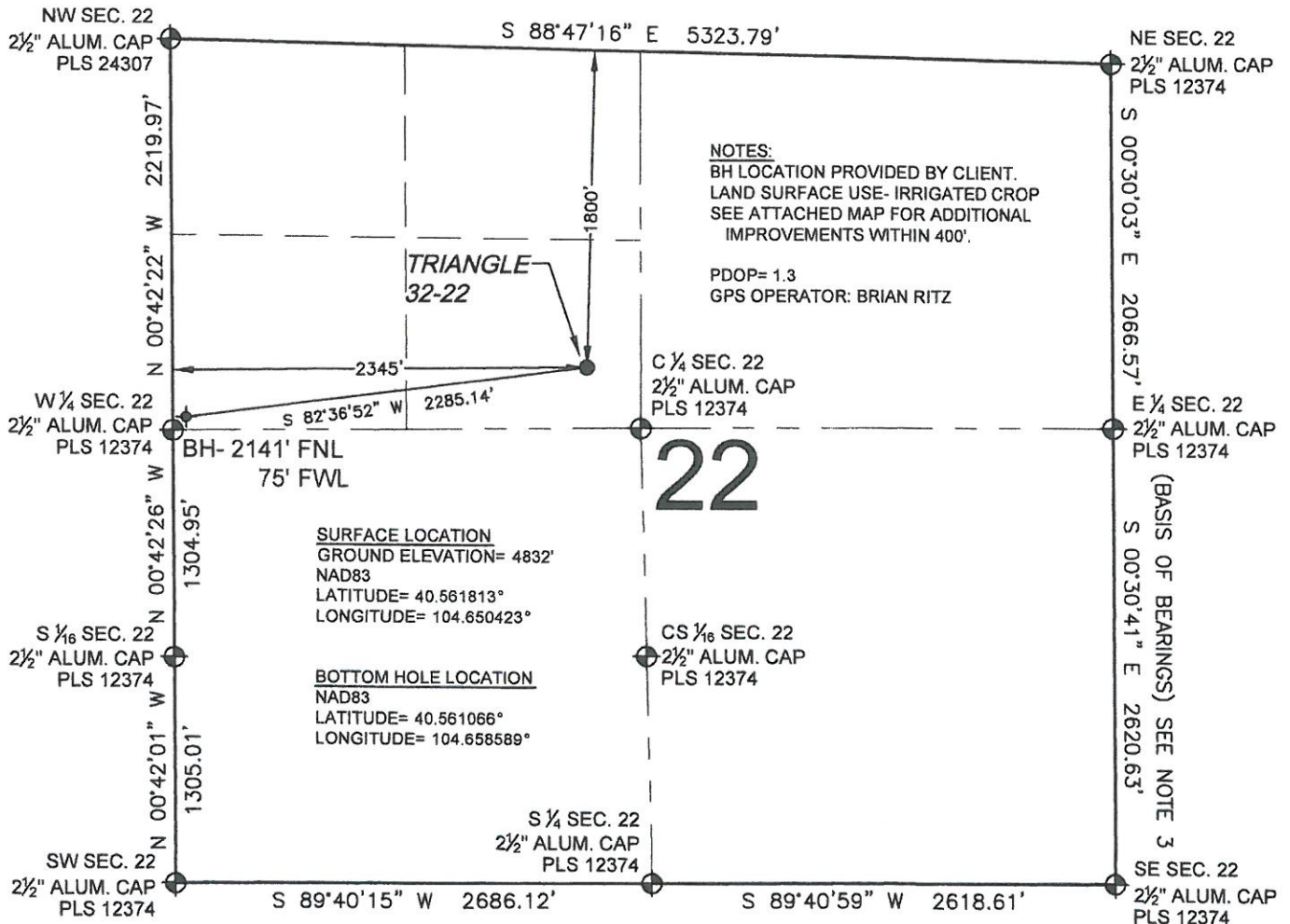


WELL LOCATION CERTIFICATE: TRIANGLE 32-22

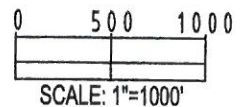
- = EXISTING MONUMENT ♦ = BOTTOM HOLE BH = BOTTOM HOLE
