On the 6th day of May, 1954, the Commission issued Order No. 32-1, Cause No. 32, which order provided for 40-acre drilling and spacing units for the production of oil from the "D" sand pool underlying Sections Three (3), Four (4), Five (5), Eight (8), Nine (9), Ten (10), Fifteen (15), Sixteen (16), and Seventeen (17), Township One (1) South, Range Fifty-six (56) West of the 6th P.M., Washington County, Colorado; and Sections Thirty-two (32), Thirty-three (33), and Thirty-four (34), Township One (1) North, Range Fifty-six (56) West of the 6th P.M., Morgan County, Colorado, which area is referred to as the Bobcat Field.

Development of the Bobcat Field since the issuance of said Order No. 32-1 indicates that portions of the area included in Order No. 32-1, Cause No. 32, should be deleted.
