The Surface Use Agreements supplied with each of the Form 2As (Doc 400373765 & 400380172) for the Cockroft B15-69-1HNM & Holman B15-65HNM locations include an Exhibit that shows production facilities will be constructed on the Cockroft location. However, you have submitted the Holman Form 2A for a production pad that will be located just south of the Cockroft location and indicates that the Holman production facility will include facilities for both the Holman and Cockroft wells. That is, the information in the SUAs conflicts with the information on the Form 2A for the Holman B15-65HNM Tank.

Can you reconcile this conflicting information for me?
