The Triton #1 is a commercial disposal well. There is no mineral lease because there are no minerals associated with this well. Ground water levels determined from the water well (Permit# 64229--) 327 feet to the south of the proposed well location. There is no significant difference between the elevation of the Triton #1 well location and the water well. Static water level is 17' below surface so this location has been deemed a sensitive area.
