33. Comments A sundry to change BHL, TD, surface and production casing program approved on 03/28/2013 to change original APD. Will be a tapered hole. Conductor casing will change from 0-40' with a 24" hole and 16" casing size to 0-60', with a 24" hole and 16" casing size. Surface casing will go from 0-200' with a hole size of 14-3/4" and casing size of 9-5/8". Surface casing will continue from 200'-1126' with a hole size of 12-1/4" and casing size of 9-5/8". Production casing will change from 0-10669' with a hole size of 7-7/8 and casing size of 4-1/2" to a tapered hole: from 0-8298' with hole size of 8-3/4" and casing size of 4-1/2". And continue on from 8298-10473' with a hole size of 7-7/8" and casing size of 4-1/2"
