The COGCC is requesting concurrence with the following Conditions of Approval (COAs) for the proposed Zukowski 17 and Moran Trust 2 well locations. Please note that although the COGCC has communicated with the Arapahoe County LGD regarding these proposed locations, the COAs listed in this email are specific to the COGCC permits and are separate and independent of any agreements between Conoco and Arapahoe County. Therefor the COGCC is requesting that Conoco reply to this email in writing with Conoco's decision to address or not address each item and if appropriate, a Best Management Practice (BMP) for each item. Please contact me if you have questions/concerns.

Conditions of approval (previously requested for Moran Trust 2):

1. Operator shall post 24-hour company contact information at the intersection of the access road and public road concurrent with MIRU.
2. Operator shall concurrently submit copies of any Form 19 submitted to COGCC for this Well or its Production Facilities to the LGD for Arapahoe County.
3. Operator will implement best management practices that address the timing and planning of mobilization, hauling, and construction operations to minimize conflicts with school bus routes.

Conditions of approval (new requests):

4. Operator will direct lights downward or use light shielding except where safety is potentially compromised.
5. Operator will comply with the Visual Impact Mitigation rule (Rule 804) due to the proximity of well traveled roads to the proposed location.
