Surface casing will go from 0-200' with a hole size of 14-3/4" and casing size of 9-5/8". Surface casing will continue from 200'- 1103' with a hole size of 12-1/4" and casing size of 9-5/8" Production casing will go from 0-7965' with hole size of 8-3/4" and casing size of 4-1/2". And continue on from 7965'- 10140' with a hole size of 7-7/8" and casing size of 4-1/2". A revised directional survey and location plat are attached, all other attachments remain the same.
