Dear Mr. and Mrs. Kos:

Encana Oil & Gas (USA) Inc. ("Encana") has staked the Rodman Bruntz 2E-26H well at a surface location 572 feet from the north line and 2077 feet from the west line of Section 26, Township 2 North, Range 66 West (see attached Well Location Certificate). This well is being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 603.a. Statewide Setbacks. This rule states:

- (2) A well shall be a minimum distance of one hundred fifty (150) feet from a surface property line. An exception may be granted by the Director if it is not feasible for the operator to meet this minimum distance requirement and a waiver is obtained from the offset surface owner(s). An exception request letter stating the reasons for the exception shall be submitted to the Director and accompanied by a signed waiver(s) from the offset surface owner(s). Such waiver shall be written and filed in the county clerk and recorder's office and with the Director.

The Rodman Bruntz 2E-26H well was staked at a location 146' from your property line. Encana respectfully requests your consent to an exception location for this well by waiver of the COGCC Rule 603.a (2).

If this meets with your approval, please sign and date both originals of this letter, keeping one for your files and returning one to the undersigned.
